PRESIDENT ELECT – Susan Lewis

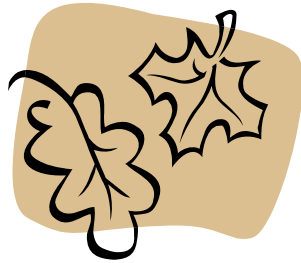
Happy Fall Everybody.

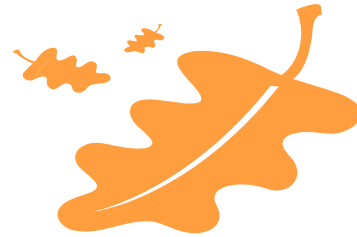

Thank you to all members who have renewed their memberships and welcome to all new members. The revamped LAW website is now interactive and available for many things such as applying/renewing membership, viewing upcoming events, enrolling for seminars, and participating on bulletin boards. Using the online applications is now the only way to become a new member or renew your membership. Once you log in to the site, you will have four choices under the *Membership* tab. If you are a current LAW member, choose the Membership Renewal Form. Choosing the *Active Membership Application* will result in the system charging you \$75.00 rather than the \$60.00 renewal fee. We've had a few glitches as we all learn to use the new system, but we expect it will make the membership process more efficient and cost effective.

I decided to become involved again because I'm concerned about enrollment and participation and would like to do something to help. One of the big buzz items at this year's convention was the new electronic voting system for officers and board members, which not only simplified the process, but freed up time to allow for one more presentation. Leave it to NALA to never let a convention attendee experience a dull or free moment when attending the convention! I think NALA will need to spruce up the Annual Meeting with the elimination of the elections because it was very apparent that attendance was low during the annual meeting as a result of the electronic voting procedure. CLA Review Course

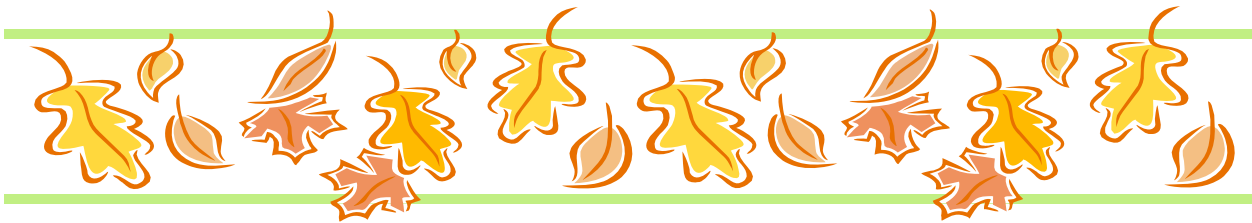
