

WHAT ARE YOU READING?


Right now, I am reading materials for the Discovery ACP course!

NALA'S CERTIFIED PARALEGAL CHAMPION AWARD

THE 2020 AWARD IS PRESENTED TO

Amanda Nelson, ACP

Amanda Nelson has recognized and promoted NALA's Certified Paralegal Program as a national professional standard for paralegals by her personal pursuit of her CP and ACP certifications as a paralegal in Wyoming, where such certifications are generally not sought after or required by employers. Ms. Nelson's tenacity to earn and maintain her certifications in a state where most paralegals are not certified has impressed upon her employers and co-workers that the professionalism and proficiency of a paralegal are defined and improved through NALA's Certified Paralegal Program.

Ms. Nelson has demonstrated passion and enthusiasm for the Certified Paralegal Program with advocacy and outreach within the association as well as in the community. Ms. Nelson has consistently served on the board of NALA affiliate Legal Assistants of Wyoming (LAW) for many years. In her various roles on the board, she has promoted the CP/ACP credentials to LAW members and paralegal students across the state, giving presentations on the benefits of certification at LAW seminars and at community colleges in Casper and Cheyenne.

Most recently, Ms. Nelson has used her new platform as the Director of the Casper College Paralegal Program to promote the Certified Paralegal Program. She has had members of the LAW board come to present in her classroom about the benefits of obtaining the NALA CP and ACP credentials, as well as LAW and NALA membership and awards opportunities.

In her various roles in LAW, Ms. Nelson has helped to promote LAW's Future CP Attainment Award, which is a scholarship LAW awards annually that pays the registration fee for a LAW member to take the NALA CP Exam. Ms. Nelson has sent emails, brought in presenters to her students, and helped to ensure that the award continues to be funded in the LAW budget.

Several years ago, it was Ms. Nelson's idea to implement the Paralegal Pals program through LAW, which pairs a paralegal student with a paralegal working in the community. While mentors are not required to be certified by NALA, it is highly encouraged.

Ms. Nelson has encouraged LAW to offer its first CP prep course in the spring of 2021. She is leading the way through the planning stages, and has developed a team who will assist with the implementation. Before now, Ms. Nelson has also encouraged members and students to attend the NALA Annual Conference to take the CP prep track, especially in 2020 when the conference was virtual and more cost effective.

Ms. Nelson encourages a high level of professional achievement by modeling it for association members and her students. She is a past recipient of the NALA Member Making a Difference Award, the LAW Member Making a Difference Award, and has tirelessly served year after year on the LAW board with excellence. She has moved from working as a paralegal for multiple firms to the Directorship of the Casper College Paralegal Program. To accomplish it, she had to finish her bachelor's degree, and compete with several JD's who also applied for the position.

Ms. Nelson is truly a Certified Paralegal Champion, and is well-deserving of this award.


